INSTRUCTIONS

- **Counselling is ONLINE MODE only.**
- **Don't share your login id, OTP and password with others.**
- ❖ All candidates have to register to participate in this counselling.
- ❖ Fresh choice filling and locking should be done by the candidate.
- ❖ **Candidates who wish to retain their seats in first round of counselling need not participate in this counselling.**
- ❖ The candidates who have been allotted, but not joined in All India Quota Round II are eligible to participate in this counselling.

- ❖ Candidates who are not participated/not joined in Round I counselling can also participate in this counselling.
- ❖ **As per the directions of Hon'ble Supreme Court of India in W.P.(c) 267/2017 DAR-US-SLAM EDUCATIONAL TRUST and Ors. Vs. MEDICAL COUNCIL OF INDIA and Ors. Dated 09-05-2017, the candidates joined in All India Quota Round II counselling are not allowed to vacate the seat. On similar ground the candidates who have joined in Round II of State counselling will not be permitted to vacate/resign/surrender the seat.**
- ❖ **The candidates who have taken admission in second round of allotment or carry the seat allotted in first round beyond notified date, which is not upgraded in second round, will not be permitted to vacate the seat.**
- ❖ Candidates participating by ONLINE COUNSELLING for PG DEGREE/ DIPLOMA course will have to remit a non-refundable amount of Rs. 1000/- as processing fee through online by using a Debit Card /Net Banking or Credit Card. The candidates who have already paid processing fee need not pay again.
- ❖ **Security Deposit for fresh Registration:**
- ❖ (i) Choice locking of seats in Government Medical Colleges alone – Rs.30,000/-
- ❖ (ii) Choice locking of seats in Government Medical Colleges and Government Quota seats in Self Financing Medical Colleges – Rs. 1,00,000/-.
- ❖ (iii) Candidates are instructed to keep their bank balance and transaction limits adequate, so as to pay without any hurdles and to prevent transaction/payment failure.
- ❖ If the candidate is upgraded from Self Financing Medical College to Government Medical College, the balance Security Deposit will be returned to their account after all the rounds of counselling is over.
- ❖ Candidates should make choice filling carefully.
- ❖ Vacancy position for the Courses is available on official websites.
- ❖ **Anticipated vacancies/virtual vacancies will be shown to all the candidates in order of merit by applying the rule of reservation/200 Point Roster method whichever is applicable.**
- ❖ **As per prospectus clause 32(e) 2022-2023, if there are no eligible service candidate opting for PG Degree/Diploma courses, the same will be allotted to eligible general category candidates.**

- **As mentioned in PG Government Prospectus clause 33 (a) Any remaining unfilled seats for want of adequate number of eligible candidates belonging to SCA community shall be filled by candidates belonging to SC community as per merit vice versa (G.O. (Ms.) No. 55, P & A R Dept. dated 08.04.2010). Hence SC candidates can register and choice lock for SCA seats also.**
- **As mentioned in PG Government Prospectus clause 33(b) Any remaining reserved seats in ST quota for want of adequate number of eligible candidates belonging to ST community shall be allotted to candidates belonging to SC community as per merit (G.O. (Ms.) No. 77 H & FW Dept. dated 24.02.2011.Hence SC candidates can register and choice lock for ST seats also.**
- **As mentioned in PG Government Prospectus clause 33(c) Any remaining unfilled seats in BCM community for want of adequate number of eligible candidates after exhausting the merit list shall be filled up on merit basis by candidates belonging to BC community without exceeding the quota for BC community as a whole(G.O. (Ms.) No. 30 H & FW Dept. dated18.01.2012).Hence BC candidates can register and choice lock for BCM seats also.**

- ❖ Candidates selected for admission should give a self-declaration form at the time of the reporting to the concerned Medical College that he / she is liable for forfeiture of selection / admission and liable for criminal action if suppression of facts and/or mis-interpretation is found at any time during or after the admission to the course.
- ❖ Re-allotted candidates need not pay the Security Deposit again.
- ❖ **If a candidate is allotted a seat in Government Medical College, he/she can download their provisional allotment order and join the course in the concerned Medical College on or before the stipulated date and time as mentioned in the allotment order.**
- ❖ **If a candidate is allotted a Government Quota seat in Self Financing Medical College, he/she should pay the tuition fee as fixed by the Fee Committee, download his/her provisional allotment order and join the course in the concerned Medical College on or before the stipulated date and time as mentioned in the allotment order.**

For Reported candidates in 1st round of counselling

Those who are willing for Re-allotment, they have to Register. Then their allotted seat (allotted in 1st round of counselling) will be open for Choice filling in Re-counselling of 2nd round.

For Example,

- If the Candidate (who have registered) hold M.S. Orthopedics in Chengalpattu Medical College, Chengalpattu, the seat will be available for choice filling for others. If the candidate does not get seat in re-allotment, that M.S. Orthopedics in Chengalpattu Medical College, Chengalpattu, will be treated as “Retained”.
- If the candidate gets other MD/MS/DILPOMA seat in Re-allotment, then the MS seat allotted in 1st phase of counselling will be allotted to other candidates.
- Re-allotted candidates must get relieved from earlier institution and Join in allotted college within the stipulated date and time.

For not reported candidates in 1st round of counselling:

- ❖ His/her seat (which was allotted in 1st round of counselling) treated as vacant.
- ❖ He/she cannot claim that seat (which was allotted in 1st round of counselling).
- ❖ Selection committee does not take responsibility of Connectivity error.
- ❖ The candidates should produce the following original certificates in person at the time of joining in their selected Medical College along with the scanned copy of original certificates to the concerned College.
 - a) NEET PG-2022-Score Card.
 - b) NEET PG-2022 Admit Card.
 - c) Aadhar Card
 - d) MBBS Degree Certificate or Provisional Pass Certificate and Diploma certificate.
 - e) CRRI Completion Certificate.
 - f) Permanent Medical Registration Certificate issued by the Medical Council of India / State Medical Council or Provisional Registration Certificate issued by the Medical Council of India / State Medical Council.
 - g) Community Certificate (if applicable)

- h) TNPSC/MRB (through competitive written examination) Selection & Posting Order for service candidates.
- i) Nativity Certificate/Residence Certificate from the Competent Revenue Authority (Whichever is applicable) with supportive documents.
- j) Eligibility Certificate, if applicable.
- k) Post Card size color photograph (4"x6") the same photo that has been uploaded in NEET PG-2022.

❖ Candidates are instructed to produce the above mentioned original Certificates/ Documents at the time of joining in the Medical College for certificate verification.

❖ The selected candidates have to pay entire Tuition fee, special fee and any other fees prescribed by "COMMITTEE ON FIXATION OF FEES IN RESPECT OF SELF FINANCING PROFESSIONAL COLLEGES" for the year 2022-2023 at the time of downloading the allotment order through online via RTGS.

❖ The candidates who are allotted in this counselling should join the course.

❖ **In order to prevent the seat blocking:**

The candidates who have been allotted and not joined in Round II should forfeit the Security Deposit and are not allowed to participate in further rounds of counselling.

❖ Candidates are advised to be in touch with our official websites (www.tnmedicalselection.org / www.tnhealth.tn.gov.in) for Schedule / latest updates / Results / Notices / News & Events pertaining to counselling as Selection Committee will not be individually contacting the candidates for the same.
