1.	Application form for admission to B.N.Y.S. (Bachelor of Naturopathy and Yogic Sciences) under Government surrendered seats in Self-Financing Yoga and Naturopathy Medical Colleges affiliated to the Tamil Nadu Dr. M.G.R. Medical University, for the academic session 2024-2025 can be downloaded / accessed from the following official website: <a href="http://www.tnhealth.tn.gov.in">www.tnhealth.tn.gov.in</a> .
2.	<b>METHOD OF APPLICATION FEE PAYMENT:</b> Application cost should be paid by Cash when submission of application on the day of counselling.
3.	All the candidates should submit the filled in application form downloaded from the website, with all the required documents. In addition, the candidates belonging to Open Category (OC), Backward Class (BC), Backward Class Muslim (BCM), and Most Backward Class (MBC)/Denotified Class (DNC) should remit cash of <b>Rs.500/- (Rupees Five hundred only) towards the application cost.</b> The candidates belongs to Scheduled Caste (SC), Scheduled Caste (Arunthathiyar) (SCA), and Scheduled Tribe (ST) of Tamil Nadu native are exempted from the remittance of the application cost they should submit <b>THREE copies</b> of their <b>Community Certificate</b> along with the filled in application form for claiming exemption from paying application cost.
4.	Read all the instructions carefully before filling up the application form. Fill up the application form legibly, neatly and correctly. The information will be processed using computer. Any mistake committed by the candidate will prejudice their selection.
5. 1.	Candidate should be a citizen of India.
2.	<b>NATIVITY:</b>
i.	Candidate should be a Native of Tamil Nadu.
ii.	All Candidates should produce the “Nativity Certificate”.
iii.	Nativity Certificate should be issued by the competent authority in the specified format available in the prospectus (ANNEXURE-I).
iv.	Application without a proper nativity certificate will not be considered.
v.	Foreign nationals are NOT eligible to apply for admission to B.N.Y.S. course.
	<p><b>Note:</b></p> <p>a) Nativity Certificate should be produced as per instructions for Nativity Certificate in Annexure I.</p> <p>b) Producing false nativity certificate if detected at any time later during the course of study will result in expulsion of the candidate and also initiation of criminal proceedings against the candidate as well as parents as per law.</p>
3.	<b>AGE LIMIT:</b>
	Candidates should have completed the age of Seventeen years on or before 31st December 2024. Evidence for the age (e.g., Birth Certificate, 10 <sup>th</sup> Mark Sheet, +2 Mark Sheet, etc.) should be produced.

<p><b>4.</b></p> <p>i.</p>	<p><b>EDUCATIONAL QUALIFICATIONS:</b></p> <p>Candidates should have passed in all the subjects of the qualifying examination of the Higher Secondary Certificate Examination conducted by the Tamil Nadu State Board or any other equivalent Board in the following group of subjects along with English individually.</p> <p>(a) Physics, Chemistry, Botany and Zoology. (or)</p> <p>(b) Physics, Chemistry, Biology with any other subject.</p> <p><b>Note:</b> Candidates who have passed in other board of examination (i.e., other than the Tamil Nadu State Board, CBSE and ISCE) with same subjects as mentioned above in clause 4 should produce the Eligibility Certificate from The Tamil Nadu Dr. MGR Medical University before attending the Counselling.</p>

<p>a.</p>	<p>Candidates who have passed Higher Secondary Certificate Examination in Vocational Stream, Pre-University Course in Tamil Nadu, and who used scribe, who did not study English as a subject in Higher Secondary Certificate Examination.</p>
<p>b.</p>	<p>Candidates presently pursuing the B.N.Y.S. Course.</p>
<p>c.</p>	<p><b>Candidate native of other states and studied in other states.</b></p>

**CATEGORY I- GOVERNMENT SURRENDERED SEATS IN SELF-FINANCING YOGA AND NATUROPATHY MEDICAL COLLEGES:**

Allotments of seats to B.N.Y.S. course in Self Financing Medical Colleges will be based on the Merit and following the Rule of Reservation and subject to the availability.

Government quota and Management Quota Seats of the Self-Financing Yoga and Naturopathy Colleges are allocated as follows:

8. **DURATION OF THE BNYS COURSE:**  
The duration of BNYS course is five and half years including one year of Compulsory Rotatory Residential Internship.

9. **DETERMINATIONS OF RANK OF THE CANDIDATES:**

a. Ranking will be made by merit on the basis of marks obtained by the eligible candidates in the prescribed science subjects in the qualifying examinations reduced to the base of 200 marks. The marks obtained through different Boards of Examination will be taken into account after normalization of marks.

b.	<p><b>Normalization of Marks:</b></p> <p>i) The marks obtained by the students in the relevant subjects in the qualifying examination conducted by various Boards or Authority will be equated with the marks obtained by the students in the same subjects in the qualifying examination conducted by the State Board of Tamil Nadu by adopting the method of normalization.</p> <p><b>Explanation:</b> - Under the method of normalization, the highest mark obtained by the students of various Boards in each subject will be equated to the highest mark obtained by the students of State Board in that subject and the relative marks obtained by other students in that subject will be determined accordingly.</p> <p><b>Illustration:</b> - If the highest mark secured by the student of State Board in Physics is 100, and the highest mark secured by the student of any other Board in the same subject is 90, both the highest mark will be considered to be equal to 100. If the student of the Other Board secures 60 marks in Physics when the highest mark in Physics in the same board is 90, the 60 marks will be considered to be equal to 66.66 marks as arrived at below: -</p> $100 \times 60/90 = 66.66\%$ <p>ii) After normalization of marks in the relevant subjects in the qualifying examination conducted by different Boards, the qualified students of different Boards will be merged into a common merit list.</p>
c.	<p><b>Determination of Rank of Candidates Obtaining Equal Marks (Inter Se Merit):</b></p> <p>In cases, where two or more candidates obtain equal aggregated marks for 200, the rank of such candidates shall be determined on the basis of the following order:</p> <p>(i) Percentage in Biology or Botany and Zoology taken together in qualifying examination.</p> <p>(ii) Percentage in Chemistry in qualifying examination.</p> <p>(iii) Percentage in fourth optional subject in qualifying examination.</p> <p>(iv) Date of Birth- Weightage given to seniority in age</p> <p>(v) Computerized Random number assigned. Higher value of Random Number will be taken into Consideration.</p>
10.	<p>The merit list will be published on the notice board at the office of the Selection Committee and will be posted simultaneously on the website: <a href="http://www.tnhealth.tn.gov.in">www.tnhealth.tn.gov.in</a></p>



11.	<p>The selection will be made by counselling based on the merit and applying rule of reservation as laid down by the Government of Tamil Nadu. All candidates are eligible for selection under open competition as per merit. 13.	<p><b>COUNSELLING:</b></p>												
i.	<p><b>a)</b> Selection Committee is the Designated Authority that conducts counselling for admissions to BNYS course in all Self-Financing Yoga and Naturopathy Medical Colleges in Tamil Nadu.</p>												
	<p><b>b)</b> No authority or institution shall admit any candidate to the undergraduate course in contravention of the criteria or procedure as laid down by the Selection Committee in respect of admissions and any candidate admitted in contravention of the said criteria or procedure shall be discharged.</p>												
ii.	<p>Selection will be made by counselling based on merit and duly applying the rule of reservation followed by the Government of Tamil Nadu.</p>												
iii.	<p>Counselling Schedule will be made available on the website (<a href="http://www.tnhealth.tn.gov.in">www.tnhealth.tn.gov.in</a>). Candidates can attend the counselling session based on their merit.</p>												

iv.	The candidates are instructed to visit the website at least two times a day for updates from the date of issue of application till the end of admission process without fail. Selection Committee will not be responsible for consequences resulting due to non-diligent follow-up of notices, notification and publications appearing on the website regarding admission to B.N.Y.S. Course 2024-2025 Session.
v.	One of the Parents or Guardian will be allowed to accompany the candidate to attend the counselling and they should make their own arrangements for attending the counselling session.
	<b><u>Note:</u></b>
i.	Candidates getting allotment, for any other reasons, at a later date after the counselling is over will be given a seat in the existing vacancies available in any one of the colleges irrespective of their merit of marks.
ii.	Candidates getting allotment through court orders before the cut-off date will be given a seat in the existing vacancies available at the time of Counselling when he/she actually attends.
iii.	Candidates who fail to attend the Counselling at the specified date and time will forfeit their right to admission and their names will not be considered at later phase of Counselling. However, he/she can authorize his/her parent on his/her behalf for that phase of Counselling due to any unavoidable circumstances. The parents' decision will be binding on the candidate. An authorization letter given by the candidate should be submitted by the parents along with the original documents of any one of the identification proofs such as Voter ID, Driving License, Pan Card, Passport, Aadhar Card, etc. of both the parent and the candidate as mentioned in the annexure VII and VII (A). Due to unforeseen and unavoidable circumstances, if a candidate, his/her parents/guardian could not attend the Counselling on the specified date and time, the candidate will be permitted to attend the Counselling on the subsequent date in the same phase of Counselling and he/she can only opt for the seats available at the time of Counselling and cannot claim seat as per his/her rank.
iv.	Those who do not join within the stipulated time to the particular college, to which they are allotted, will not be considered for admission at any point of time later.
v.	No candidate can opt to be waitlisted for a particular college when seats are available in other colleges for the particular Community at his/ her turn.
vi.	If a candidate opts out of (not willing to take) other category seats, when seats are available at the time of his / her t u r n , then he/she will not be eligible for the same seat at any point

d)	<b>The candidates who are allotted seats in Self-Financing Yoga and Naturopathy Medical College shall remit a Non-refundable sum of Rs.10000/- (Rupees Ten Thousand only) by Cash / Demand Draft.</b> After the conduct of Registration Subcommittee meeting by the Tamil Nadu Dr. MGR Medical University this amount will be transferred to the Self-Financing Medical Colleges concerned to get adjusted against the Tuition Fees to be paid by the candidates. <b>If the candidates fails to join the course after getting allotment order within the stipulated time, he/she will forfeit this amount and the seat allotted.</b>

- (6) The guidelines prescribed for the issue of Nativity Certificate and they are as follow as per Lr. No. R.A.V(B) –16932/2000, dated 3.4.2000 of the Special Commissioner and Commissioner of Revenue Administration, Chepauk, Chennai 5.
  - i. The parents/ guardians of the applicants/ students or the applicant themselves should have permanently resided continuously for a period of 5 years in Tamil Nadu.
  - ii. Permanently residing for a period of 5 years should be supported by documentary evidence.
  - iii. The family ration card, Electoral Roll, census list if taken recently, documents like sale deed, tax receipt etc. relating to the property owned by either of the parents or by the applicant may be verified.
  - iv. The Transfer Certificate issued by the school authorities where the applicant had studied last may be verified to know whether he/she was in the state for 5 years.
  - v. Enquiry in the village/ place of residence of the neighbor by Village Administrative Officers regarding continuous residing.
  - vi. To ensure that wrong or incorrect address had not been furnished to obtain the certificate.
  - vii. The birth place of the parent, place of the residence of the parent/ father, permanent assets, mother tongue, place of education, place of marriage of the applicant/parents, the period of stay in and outside Tamil Nadu can also be considered before issuing certificate.

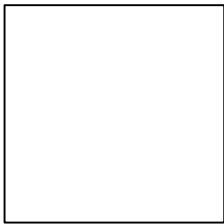

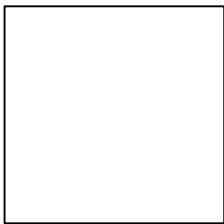
