

#### ABSTRACT

Family Welfare Establishment – Reconstitution of Permanent Medical Board for examining Medical Termination of Pregnancy cases beyond twenty four weeks of gestation – Revised Orders – Issued.

#### **ORDER:**

The Director of Family Welfare in her letter fourth read above has stated that the Secretary, Government of India, Ministry of Health and Family Welfare, has requested all the States and Union Territories to establish the Permanent Medical Boards in tertiary care hospitals to examine the Medical Termination of Pregnancy cases beyond 20 weeks of gestation as and when referred from the Courts as directed by the Supreme Court of India.

2. Accordingly, in Government Order first read above, Permanent Medical Boards have been constituted in 19 Medical College Hospitals in the State.

3. As per the recent Medical Termination of Pregnancy (Amendment) Act 2021, (a) The upper gestation limit for Medical Termination of Pregnancy has been enhanced from twenty to twenty-four weeks of gestation period for special categories of women and (b) Upper gestation limit for Medical Termination of Pregnancy will not apply in cases of pregnancies with substantial foetal abnormalities diagnosed by a Medical Board.

4. The Medical Termination of Pregnancy Rules, 2021 clearly defines the Powers of the Medical Board, Functions of the Medical Board and Composition of the Medical Board. It states that,

"The opinion for Medical Termination of Pregnancy beyond twenty-four weeks gestation period shall be given by a Medical Board duly constituted by the respective State Government or Union territory Administration"

## I) Powers of the Medical Boards:

- a. To allow or deny termination of pregnancy beyond twenty-four weeks of gestation period only after due consideration and ensuring that the procedure would be safe for the woman at that gestation age and whether the foetal malformation has substantial risk of it being incompatible with life or if the child when born would suffer from such physical or mental abnormalities to be seriously handicapped.
- b. Co-opt other specialists in the Board and ask for any additional investigations if required, for deciding on the termination of pregnancy.

### II) Functions of the Medical Boards:

- a. To examine the woman and her reports, who would approach for medical termination of pregnancy.
- b. Provide the opinion of Medical Board in Form D with regard to the termination of pregnancy or rejection of request for termination within three days of receiving the request for medical termination of pregnancy.
- c. To ensure that the termination procedure, when advised by the Medical Board, is carried out with all safety precautions along with appropriate counselling within five days of the receipt of the request for medical termination of pregnancy.

# III) The Medical Board shall consist of the following, namely:-

- a) a Gynaecologist;
- (b) a Paediatrician;
- (c) a Radiologist or Sonologist; and
- (d) such other number of members as may be notified in the Official Gazette by the State Government or Union territory, as the case may be.
- (e) Any Board Member, if not available at the point of time of discussion on a case, may be suitably substituted by another member by the Medical Superintendent or concerned administrative official.
- (f) At least one member of the Medical Board should be a woman.

5. The Director of Family Welfare has further stated that in addition to the Permanent Medical Boards established in 19 Medical College Hospitals in Government Orders first read above, the Permanent Medical Boards shall be constituted in the 11 Newly formed Medical College Hospitals and also Government Erode Medical College and Hospital, Perundurai and Government Cuddalore Medical College and Hospital, Chidambaram.

6. The Government after careful consideration of the proposal of the Director of Family Welfare for the establishment of Permanent Medical Boards at the 13 Medical College Hospitals to examine the Medical Termination of Pregnancy cases, as per the Government of India Guidelines have decided to accept the same. Accordingly, the Government issue the following orders:-

- (i) As per the Medical Termination of Pregnancy (Amendment) Act 2021, the Upper gestation limit shall not apply to the termination of pregnancy by the Medical Practitioner where such termination is necessitated by the diagnosis of any of the substantial foetal abnormalities diagnosed by a Medical Board.
- (ii) Reconstitute the Permanent Medical Boards in 19 Medical College Hospital as per Annexure A-I
- (iii) Constitute the Permanent Medical Boards in 13 Medical College Hospitals as per Annexure A-II.
- (iv) Composition of members of Permanent Medical Board as per Annexure-B.
- (v) To provide the opinion of Medical Board in Form-D to with regard to the termination of pregnancy or rejection of request for termination within three days of receiving the request for medical termination as per Annexure-C.
