**II. Family Planning Indemnity Scheme Claim for Sterilization
Failure Cases originally sterilized after 28.11.2005**

1.	Tmt.Rajeswari w/o.Thiru.Muthukrishnan No.5/25,North thevar Street, Karukuruchi, Cheranmahadevi Tk, Tirunelveli Dt.	Underwent LSCS with Sterilization on 30.03.2022 at Kani Private Hospital, Tirunelveli and pregnancy confirmed by USG & Beta-Hcg report at Rio Scans, Tirunelveli on 02.03.2023 and Emergency Laparotomy proceeded to Right Side Salpingectomy done on 03.03.2023 at Kani Private Hospital, Tirunelveli.
2.	Tmt.Maheswari w/o.Thiru.Basker No.2/157,Water Tank Street, Ullasa Nagar, Adayakarungulam, Ambasamudram Tk, Tirunelveli Dt.	Underwent Puerperal Sterilization on 14.01.2015 at Government Hospital, Ambasamudram and pregnancy confirmed by UPT & USG report at Tirunelveli Medical College Hospital, Tirunelveli on 23.03.2023 and Emergency Laparotomy proceeded to Right side Salpingectomy done on 23.03.2023 at Tirunelveli Medical College Hospital, Tirunelveli.
3.	Tmt.Anusuya w/o.Thiru.Muthumariappan No.16B/1, Chithivinayakarkovil Street,Chatrapudukulam Thachanallur, Tirunelveli Tk, Tirunelveli Dt.	Underwent LSCS with Sterilization on 13.03.2017 at Tirunelveli Medical College Hospital, Tirunelveli and pregnancy confirmed by UPT & USG report at Tirunelveli Medical College Hospital, Tirunelveli on 17.04.2023 and Emergency Laparotomy proceeded to Right Side Salpingectomy and Left side Fimbriectomy done on 17.04.2023 at Tirunelveli Medical College Hospital, Tirunelveli.

4.	Tmt.Cathrine w/o.Thiru.Mariappan No.309,Ambethkar Street, Thiruchitrabalam, Tirunelveli Tk, Tirunelveli Dt.	Underwent Puerperal Sterilization on 31.07.2019 at Tirunelveli Medical College Hospital, Tirunelveli and pregnancy confirmed by UPT & USG report at Sri Ram Hospital,Alangulam & Tirunelveli Medical College Hospital, Tirunelveli on 09.02.2023 &10.05.2023 and MTP done on 09.02.2023 at Sri Ram Hospital, Alangulam and TAT done on 15.05.2023 at Tirunelveli Medical College Hospital, Tirunelveli.
5.	Tmt.Saranya w/o.Thiru.Siva No.1/25 SivankovilStreet, Ambalavanarpuram, Radhapuram Tk, Tirunelveli Dt.	Underwent LSCS with Sterilization on 19.11.2019 at CSI Bellpins Hospital, Tirunelveli and pregnancy confirmed by UPT & USG report at Kilpauk Medical College Hospital, Chennai on 24.03.2023 and Emergency Laparotomy proceeded to Left Side Salpingectomy and Right side Resterilization done on 24.03.2023 at Kilpauk Medical College Hospital, Chennai.
6.	Tmt.Petchiammal w/o.Thiru.Velkumar No.1 Indra Nagar, Singikulam, Nanguneri Tk, Tirunelveli Dt.	Underwent Puerperal Sterilization on 01.09.2014 at Government Primary Health Centre, Thirukkurankudi and pregnancy confirmed by UPT & USG report at Tirunelveli Medical College Hospital, Tirunelveli on 27.05.2023 and Emergency Laparotomy proceeded to Left Side Salpingectomy and Right side Fimbriectomy done on 27.05.2023 at Tirunelveli Medical College Hospital, Tirunelveli.

The Chairman of the committee ascertained that the failure rate of sterilization is within the acceptable limit and the failure cases should be followed at the initial stage and sterilization to be done following with D&C or MTP, as the case may be.

The District Collector instructed the Deputy Director of Family Welfare to study the reason for failure and take necessary steps to keep the failures in acceptable limit.

Then the Committee accepted the reasons of the above Six failure of sterilization cases and recommended for the Family Planning Indemnity scheme claim as per the Government of India Norms.

The Deputy Director of Medical Rural Health Services & Family Welfare, Tirunelveli was informed to adopt and adhere to the instructions and guidelines issued by the Director of Family Welfare Chennai for the Family Planning indemnity scheme claim for the above eligible cases.
