Cases originally sterilized after 28.11.2005**



Underwent Puerperal Sterilization on 26.08.2017 at Government Primary Health Centrel, Kadayam and pregnancy confirmed by USG report at Aarthi Scans, Tenkasi on 08.03.2023 and Emergency Laparotomy proceeded to Left Side Salphingectomy done on 08.03.2023 at Balaji Hospital, Tenkasi.
2.	Tmt. Arunmozhi, W/o. Thiru.Maruthaiah , 1/4, Bharathiyar 8th Street, Sankarankovil, Sankarankovil Taluk, Tenkasi District.	Underwent LSCS with Sterilization on 05.10.2018 at Government Hospital, Sankarankovil and pregnancy confirmed by UPT & USG report at Tirunelveli Medical College Hospital, Tirunelveli on 23.03.2023 and Emergency Laparotomy proceeded to Total Bilateral Salphingectomy done on 23.03.2023 at Tirunelveli Medical College Hospital, Tirunelveli.
3.	Tmt. Kala, W/o. Thiru.Magesh , 33B, Vadakku Villai Colony Street, Kumanthapuram, Kadayanallur Taluk, Tenkasi District.	Underwent Laparoscopic Sterilization on 22.02.2019 at Government Primary Health Centre, Chokkampatti and pregnancy confirmed by UPT & USG report at Government Hospital, Kadayanllur on 16.04.2023 and MTP with TAT done on 24.04.2023 at Government Hospital, Kadayanallur.
4.	Tmt. Jothi, W/o. Thiru.Illayaraja , 1A, Kilaparaiyadi Street, Tenkasi Taluk, Tenkasi District.	Underwent LSCS with Sterilization on 02.06.2019 at District Head Quarters Hospital, Tenkasi and pregnancy confirmed by UPT & USG report at Tirunelveli Medical College Hospital, Tirunelveli on 03.05.2023 and Emergency Laparotomy proceeded to Left Side Salphingectomy done on 03.05.2023 at Tirunelveli Medical College Hospital, Tirunelveli.
5.	Tmt. Simona Fyrose, W/o. Thiru.Rajesh Kanna , 36, North Street, Kurtrallam Kudiruppu, Tenkasi Taluk, Tenkasi District.	Underwent Laparoscopic Sterilization on 09.05.2022 at Government Primary Health Centre, Elathur and pregnancy confirmed by UPT & USG report at Government Hospital, Kadayanallur on 04.03.2023 and MTP with TAT done on 06.03.2023 at Government Hospital, Kadayanallur.


The Chairman of the committee ascertained that the failure rate of sterilization is within the acceptable limit and the failure cases should be followed at the initial stage and sterilization to be done following with D&C or MTP, as the case may be.

The District Collector instructed the Deputy Director of Family Welfare to study the reason for failure and take necessary steps to keep the failures in acceptable limit.

Then the Committee accepted the reasons of the above Five failure of sterilization cases and recommended for the Family Planning Indemnity scheme claim as per the Government of India Norms.

The Deputy Director of Medical Rural Health Services & Family Welfare, Tirunelveli was informed to adopt and adhere to the instructions and guidelines issued by the Director of Family Welfare Chennai for the Family Planning indemnity scheme claim for the above eligible cases.
